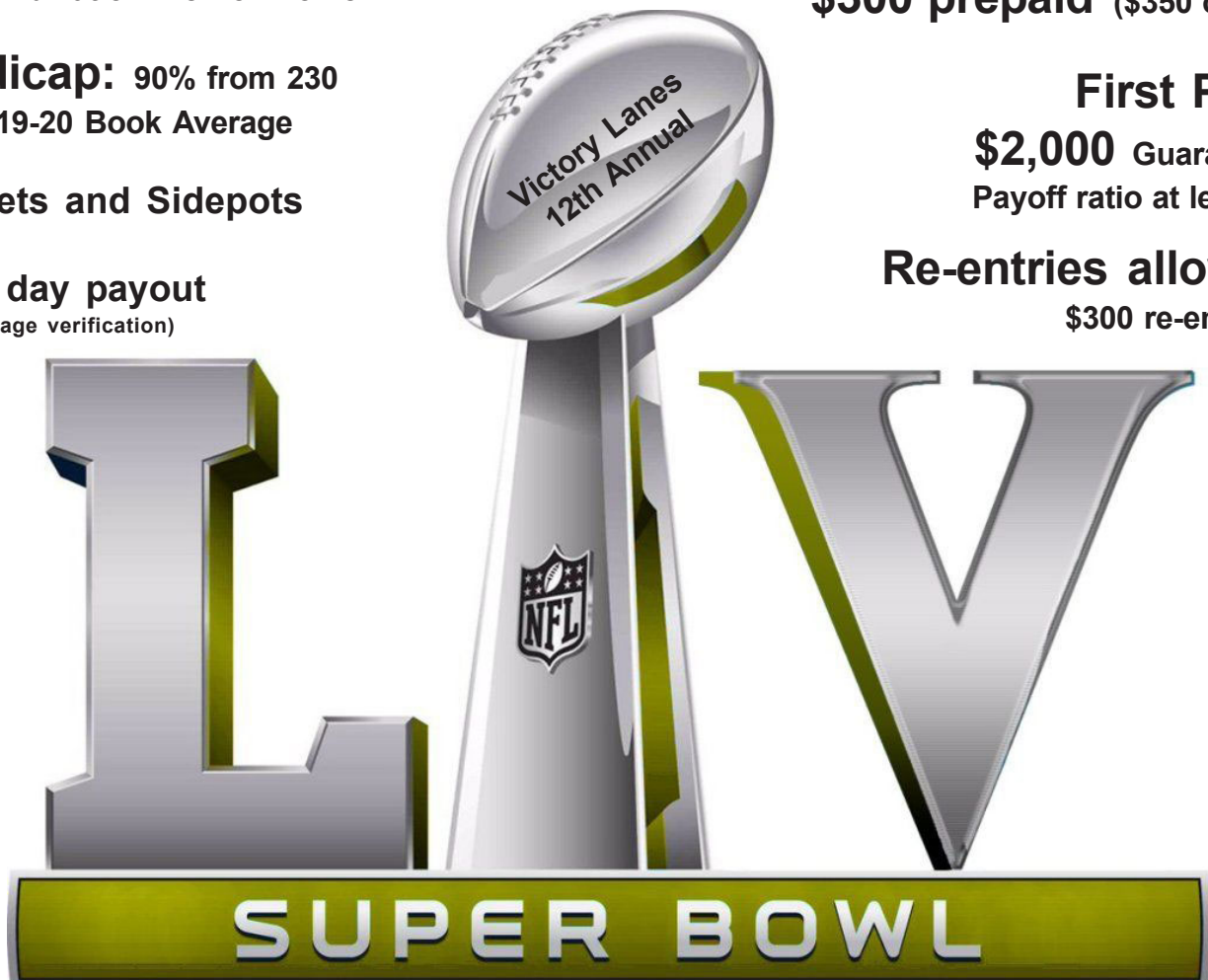

12th Annual Super "Bowling" Team Challenge

Super Bowl Sunday, February 7, 2021 -- Two squads: 9:00 a.m. and 1:30 p.m.

RULES, FORMAT and ENTRY FORM

1. This tournament will be USBC Certified. USBC rules and regulations will govern this tournament.
2. Teams will be made up of five (5) members. Teams may be any combination of men, women or mixed.
3. Teams will bowl three (3) games on ONE PAIR of lanes.
4. The tournament will be held on Sunday, February 7, 2021. **Squad times will be at 9:00 a.m. and 1:30 p.m.** Entries will be accepted up until **30 minutes before** each squad time or until the squad fills.
5. Bowlers will use their **HIGHEST certified league average from the 2019-20 season** (21 games or more). If none, use highest CURRENT league average (21 games or more). If none, the tournament director may assign an average based on prior years' book averages, otherwise, the bowler may bowl scratch.
6. **Please note:** A bowler with a current (2020-21) season average, as of January 1, 2021, which is ten or more pins higher than their previous season (2019-20) average, shall use their CURRENT average (as of January 1, 2021).
7. Bowlers shall submit themselves for re-rating in this tournament and shall be re-rated before bowling according to the re-rating requirements of the USBC rules. The tournament director reserves the discretionary right to re-rate ANY bowler prior to the start of the tournament.
8. All handicaps will be figured on the basis of 90% of the difference in the bowler's average and 230.
9. Bowlers are responsible for the accuracy of their averages. All averages must be verified prior to any prize disbursement. Any certified averages outside of the Rowan-Mooresville USBC Association must bring average verification to the tournament or be verifiable through Bowl.com.
10. **Entry fees:** The TEAM entry fee will be \$300 if paid by 11:59 p.m. Saturday, February 6, 2021. The on-site entry fee will be \$350 per team. Breakdown: \$235/\$285 prize fund; \$60 bowling fees; \$5.00 expense fee.
11. The prize ratio will be at least 1 in 6 entries.
12. **MULTIPLE TEAM ENTRY RULE** - A team may re-enter the afternoon squad for \$300. To CASH more than once, a team re-entering the afternoon squad must have at least two bowlers different than the team entered in the morning squad.
13. **Side pots:** There will be optional side pots and optional brackets.
14. The Tournament Director reserves the right to make the final decision on all issues in the best interest of the Tournament.
